Clarification of News Report

On June 9, 2020 Manila Standard published an article, "Jolly Ting shuts down Pegasus, Heartbeat, Air Force One." In particular, the article stated:

"Employees of several high-end entertainment clubs....have received separation pay from Jolly Ting, the chairman and chief executive of publicly listed Jolliville Holdings Corp., according to sources."

"Supervisors and employees of the KTV bars owned by Jolliville or the Ting family were informed that the clubs would no longer resume operations because of the huge impact of the health crisis."

Jolliville Holdings Corporation (JOH or the Company) would like to clarify that the above statements are false and contradictory to an accurate statement found in the latter portion of the same article.

JOH "leases and rents out certain assets...to a number of independent business entities involved in the operation and management of KTV entertainment/recreation centers in Metro Manila area."

On June 9 2020, 10:35 pm, Manila Standard also published the article "Virus casualties: Night club chain to fade out lights, Corregidor ferry service to stop" In particular, the article stated:

"Jolly Ting, chairman and chief executive of publicly-listed Jolliville Holdings Corp., has sent out separation pay to employees of several high-end entertainment clubs and KTV bars in Metro Manila's pleasure districts, including Pegasus Ultimate Men's Club, and Heartbeat Mega KTV, a well-informed source said Tuesday."

"Jolliville rents out the facilities to these night clubs and KTV bars while an outsourcing unit of the company provides the staff and talents for their operations."

"Sources said thousands of regular employees and talents, mostly dancers and guest relations officers, under Servwell BPO International Inc., Jolliville's outsourcing unit which provides the staffing needs of different KTV operators in Metro Manila, were expected to lose their source of income."

JOH would like to clarify with the investing public that the Company is a lessor to the independent businesses in the KTV entertainment/recreation business while Servwell BPO International Inc, a JOH subsidiary, provides technical services and back office support. Servwell does not employ thousands of employees, nor does the company provide talents and staffing needs to said clients.

JOH have been informed of the temporary suspension of our clients' business in light of the COVID-19 pandemic. It may be expected that lease payments and service contracts with these clients may be reviewed and renegotiated, while clients' operations remain suspended.

JOH and its subsidiaries do not have any business relationship with Air Force One.

We hope this clarifies the misinformation as stated in the above articles.
